We have had great support from the CCG (now ICB) with respect to the GP CPCS service. The CCG have paid for the IT platform making referrals very simple from the GP surgery straight to PharmOutcomes. This alarm flashes when a referral comes through, allowing you to complete the consultation in a timely manner. As an LPC we have also given some funding so we could have people going into surgeries to train the team on the service. Additional funding has been given to us for PCN leads which we are looking forward to introducing to you all later in 2022, with a clear plan on how the LPC will use this funding to support PCN leads in being the best that they can be in the role without losing income when participating in the role of a PCN lead.
